3. Rate should be given on per Km basis including toll taxes/ other charges etc.
4. Rate of night charges should be given separately.
- 5.The responsibility of taxes/charges etc as per Govt. rule will be of party/firm.
6. Responsibility of any kind of damage/accidents etc during work will be of party/firm.
7. Advance will not be given to firm/party. Payment will be given after completion of work.
