The service charges quoted by firms M/s Ram Krishna Vidhya Samiti Atru Road Baran,1131 Subhash Nagar-11 Kota/Atru Road, Baran and M/s RSB Security, 97 Ashok Vihar, Ambawari, Jaipur were not considered valid keeping in view RTPP Act(2-xiii) as the amount was Rs 0.01paisa. The committee recommends rates quoted by M/s Active Security Services, F-16, Rajputana Tower, Jaswant Nagar, Khatipura, Jaipur for security/chowkidar at SKNCOA,Jobner for approval.
