Limited Tender Notice

Sealed tenders are invited from the reputed firms for hiring JCB services for carrying out different farm works like field partition, bund making, leveling of obstruction bund, FYM application, digging of perennial plants/bushes like wild aok, kheep, wild babool etc. The tenders will be accepted up to **11:30 AM on 10.08.2021** and will be opened at **02:15 PM** on the same day at College of Agriculture, Lalsot (Dausa). Bidders have to quote their rate/hour in the given proforma only. The committee has all right to accept/reject any tender without assigning the reasons thereof. The approximate hiring/purchasing can be increased/decreased.

TERMS & CONDITIONS

1. Tenders received after the prescribed time and date will be rejected.
2. Tenders must be accompanied by **tender fee of Rs. 500** and **Earnest money of Rs. 3900.0** in cash or demand draft in favour of the **Dean, COA, Lalsot**, failing which the tender will not be accepted. **Successful bidder will have to deposit 5% performance security (Rs. 9750.0 including 2% of Earnest money deposited earlier)** before placing work order. Earnest money will be returned to the non-successful firms after finalization of the tender and successful bidders after satisfactory completion of the tender period. If the bidder does not provide timely and satisfactory services, performance security will be forfeited and will not be returned.
3. No counter proposals or modification by the firm/bidder will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice, it will be under applicable to acceptance of terms and condition given by us and no claim of counter proposals stated in the tender will be entertained.
4. JCB operating driver should have a valid driving license. No advance payment will be made.
5. Tenderer should submit photocopy of GST registration and PAN No.
6. The responsibility of GST/other charges applicable on these works as per Government rules, will be borne by the bidder.
7. Any kinds of damage to machinery/ mishappening to the operating person will not be claimable and will be responsibility of the bidder.

8. Supply of hire service by JCB will have to be made within 1-2 days from the date of the order.
9. The rates of tender shall be valid for a period of one year from the date of work order. After completion of one year, this period can be extended by mutual agreement but not exceeding the limit of **1.95 Lakhs**.
10. Rate contract for services of the JCB will be mentioned in Rs./hour only.
11. On the cover containing the tender should be written "Limited tender for the supply of JCB Services".
12. The decision of accepting authority shall be final as to the quality of the stores.
