FINANCIAL BID

Tenders were invited for hiring buses for exposor visit in college vide tender No. F./Store/ACL/2023/717 dated 05.09.2023. In this process, five bids were received, out of which, single firm was found responsive in technical and financial bid and opened on 13.09.2023 and 14.09.2023, respectively. Since responsive firm *i.e.* Ravindra Singh C/o Gaytri Tour and Travels, Police Line Road, Sikar (Raj.) was single committee recommended for negotiation. Negotiation took place between committee and firm vide office order No. F./Store/ACL/2023/750 Dated 15.09.2023. Rates of responsive firm before and after negotiation are mentioned as below:

Since single firm was responsive which falls under the lack of completion criteria, committee critically reviewed the mentioned below points in pursuance of Rule 68 (RTPP 2013)†

- The bid is technically qualified;
- The price quoted by the bidder is assessed to be reasonable for hiring of buses for exposure visit in Rajasthan and other state/s
- The bid is unconditional and complete in all respects;
- There are no obvious indicators of cartelisation amongst bidders; and
- The bidder is qualified as per the provisions of section 7

Having reviwed the Rule 68 (RTPP 2013), the committee found that rates quoted by Ravindra Singh C/o Gaytri Tour and Travels, Police Line Road, Sikar (Raj.) for hiring of buses for exposure visit in Rajasthan and other state/s were reasonable. Hence the committee recommends rates after negotiation for hiring of buses for exposure visit in Rajasthan and other state/s for approval.
