The bidder No. 1/4 GC LIFE SCIENCES, JAIPUR has furnished Last Two-year satisfactory installation reports for Instruments only and is fulfilling the Conformity of specifications of the Laboratory Equipment's as per the tender. The bidder No. 4/4 SUPREME SPORTS, BHARATPUR has furnished Last Two-year satisfactory installation reports for Sports Items only and is fulfilling the Conformity of specifications of the Sports Items as per the tender. Thus, the bidder No. 1/4 i.e., GC LIFE SCIENCES, JAIPUR and 4/4 i.e., SUPREME SPORTS, BHARATPUR have submitted all the relevant documents for Laboratory Equipments and Sports Items, respectively. After evaluation by the competent committee the bidder No. 1/4 i.e., GC LIFE SCIENCES, JAIPUR and 4/4 i.e., SUPREME SPORTS, BHARATPUR have fulfilled all the technical requirements and are eligible for LABORATORY EQUIPMENT'S and SPORTS ITEMS, respectively. So, the committee recommends opening of their financial bids (GC LIFE SCIENCES for LABORATORY EQUIPMENT'S) and (SUPREME SPORTS, BHARATPUR for SPORTS ITEMS).
