### Limited Tender Notice

Sealed tenders are invited from the reputed firms for hiring BACK HO LOADER (JCB) services for carrying out different farm works like field partition, bund making, leveling of obstruction bund, digging of perennial plants/bushes like wild babool, making of kachha road and drainage channels etc. as and when required in the College for the current financial year (2026-27). The tenders will be accepted up to 11:30 AM on 30.06.2026 and will be opened at 12:15 PM on the same day at College of Agriculture, Kumher (Deeg). Bidders have to quote their rate/hour in the given proforma only. The committee has all rights to accept/reject any tender without assigning the reasons thereof. The approximate hiring can be increased/decreased as and when required.

#### TERMS & CONDITIONS-

1. Tenders received after the prescribed time and date will be rejected.
2. Tenders must be accompanied by tender fee of ₹ 200 and Earnest money of ₹ 3900.00 in UPI or demand draft in favour of the Dean College of Agriculture Bharatpur, failing which the tender will not be accepted. Successful bidder will have to deposit 5% performance security (₹ 5850.0 including 2% of Earnest money deposited earlier) before placing work order. Earnest money will be returned to the non-successful firms after finalization of the tender and successful bidders after satisfactory completion of the tender period. If the bidder does not provide timely and satisfactory services, performance security will be forfeited and will not be returned.
3. No counter proposals or modification by the firm/bidder in terms and conditions of the tender will be acceptable.
4. BACK HO LOADER (JCB) operating driver should have a valid driving license. No advance payment will be made.
5. Tenderer should submit self-attested photocopies of AADHAR, GST registration and PAN No.
6. The responsibility of GST/other charges applicable on these works as per Government rules, will be borne by the bidder.
7. Any kinds of damage to machinery/ mishappening to the operating person will have no claim on the part of the college and will be sole responsibility of the bidder.
8. Supply of hire service by BACK HO LOADER (JCB) will have to be made within 1-2 days from the date of the order.

9. The rates of tender shall be valid for a period of one year from the date of work order. After completion of one year, this period can be extended by mutual agreement but not exceeding the limit of 1.95 Lakhs.
10. Rate contract for services of the BACK HO LOADER (JCB) will be mentioned in ₹/hour only.
11. On the cover containing the tender should be written "Limited tender for the supply of BACK HO LOADER (JCB) Services".
12. The decision of accepting authority shall be final as to the quality of the stores.
13. The requirement of BACK HO LOADER (JCB) Service minimum 5 hours in a day.
