#### **Common Terms & Conditions:**

1. Bids (Technical & Commercial) in separate sealed cover with company seal and signature on every page are invited for and on behalf of SKNCOA, Jobner. Please super scribe the above-mentioned Title and date of opening of the Bids on the sealed cover to avoid the Bid being declared invalid. **Both the envelopes must be enclosed in a third sealed envelope and super scribed with the Tender number and due date.**
2. **The firm must attach atleast one govt. work order for experience in similar domain.**
3. The bidder must sign and seal all the tender documents.
4. The rates quoted for the articles should include installation, taxes and other charges, if any, FOR Jobner.
5. Service Tax, if applicable must be mentioned in the quotation.
6. **The firm has to submit their GSTIN/service tax/VAT/TIN registration number along with the quotation otherwise the tender will not be considered**
7. The firm must have executed at least one work order in the field of networking (**attach proof**)

### TERMS AND CONDITIONS

1. **A Bid Security amount of Rs. 4000/- will be deposited by the selected firm (Work order awardee)**
2. The payment will be made quarterly only after submission of satisfactory report from the concerned department.
3. **The cost of new/replaced part/item will be borne by the firm.** The firm has to keep all the equipment in working order.
4. The firm should be in existence for over 3 years in the trade with minimum average turnover of Rs. 6.00 lacs in the last three financial year (CA Certified).
5. The firm also must have expertise and experience in LAN troubleshooting. The bidder should have executed satisfactorily minimum of one Annual Maintenance Contract of more than 100 Computers connected in LAN under Window/ Linux/ NT environment for at least two years consecutively.
6. List of Engineers to be deployed in Trust with their detailed bio-data showing their qualification, experience and mobile number.
7. Any information/date/credentials that the contractor or any of his employees may come to possess or know during the course of their work will not be disclosed to any one in any form and there Levant portions of the official Secrets Act would be applicable.
8. **The scope of work covers provision of technical staff in campus from 10:00 AM to 5:00 PM on all working days and if required, on Saturdays and Sundays and also after 5:00 PM on working days.** Minimum one qualified service engineers in computer/electronics/telecommunication engineering' with an experience of not less than 3 years in computer hardware.
9. **The engineer(s) shall be required to report at least Five days a week on working days**



10. The engineers deployed shall be responsible for at least 90% uptime of overall network. He should frequently visit campus and hostels to check the availability of internet and web resources and should maintain a register to mark satisfactory working from the respective office/department.
11. The engineer will sign the attendance register of contractor on every visit with timing, kept in Internet Cell. **Engineer deployed by the contractor shall work in coordination with Incharge, Internet Cell, SKNCOA, Jobner.**
12. The expansion of network, if any in the campus and university will be done by the firm without any extra charges.
13. No Visit Charges should be claimed by firm in any manner during the AMC period.
14. In case the part(s) have to be replaced it should be changed at site.
15. If the representative of the firm does not visit the college /complete a visit satisfactorily, then a penalty in the form of a deduction at the rate of 5% from the tendered amount shall be done for the same.
16. If the firm is imposed penalty for the three successive visits, then both the earnest money and the security deposited shall be forfeited and the contract may be terminated. The final payment in such a case will be made after deducting the penalties.
17. If the equipment is required to be transported to the firm's/manufacture's service workshop for repairs, the same shall be undertaken at the risk and cost of the firm
18. The replacement of components shall be as per manufactures instructions and as per the decision of Head of Office/Department.
19. The firm shall have the required drivers (CDs or External HDDs) for maintaining the PCs and networking peripherals for configuring them.
20. It shall be the responsibility of the firm to make all the Aps (indoor & outdoor), sector/omni antennas & other networking devices work satisfactorily throughout the contract period and to hand over the systems in working condition to the Department after expiry of the contract. In case any damage is found, the firm is liable to rectify in even after the contract.
21. The firm will have to execute rate contract on Rs. 100/- Non Judicial Stamp for agreement after placing work order.
22. The rate offered by the firm for different items shall be considered by counting of one unit.
23. The tenderer must put his **signature and stamp on every paper** of tender including terms and condition.
