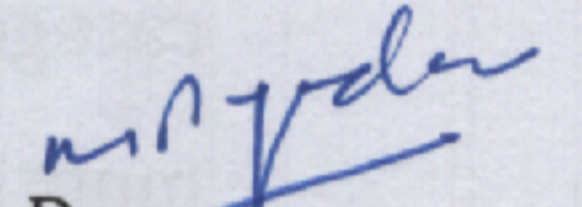

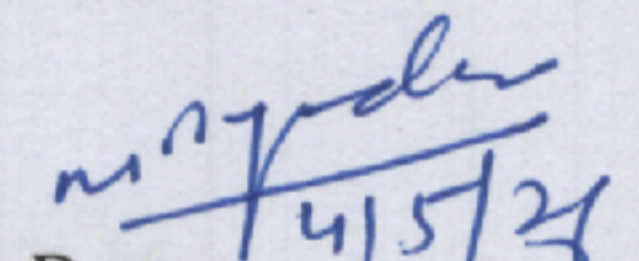
1. The wages of the workers engaged by the firm shall be mandatorily deposited in their respective bank accounts. The firm shall submit details of such wage payments, duly reflecting the transfer of amounts into the workers' bank accounts, to this college along with the monthly bill by the 5th of every month.
2. The firm shall also furnish a certificate confirming that the monthly EPF, ESI contributions, and all other applicable statutory deductions in respect of the engaged workers have been deposited in their respective accounts within the prescribed time. It is responsibility of concerned firm that paying the wages to the workers will be according to the GOR and the rates of wages shall be applicable if GOR revise these wages by suitably notification in future.

3. All works will have to be done under the supervision of the undersigned or Officer who is assigned this responsibility.
4. Work has to be done as per the terms and conditions given under the tender form of the office. All the terms & conditions of the tender and guidelines and order in this regard issued time to time by the University/College/GOR must be followed by the firm/Service provider.
5. You are informed that, as per the tender conditions, a Non-Judicial Stamp of ₹500/- is required. In accordance with the terms and conditions of the tender, you are requested to accept all rules and conditions and submit the agreement letter along with the performance security amount of 5% (₹49,500/-). Out of this, an amount of ₹19,800/- has already been deposited; therefore, the balance amount of ₹29,700/- is required to be submitted in the form of a Demand Draft in favour of the Dean, College of Agriculture, Kishangarhbas, payable at Kishangarhbas, at the earliest so that further necessary action may be carried out
