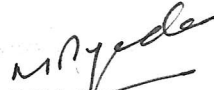

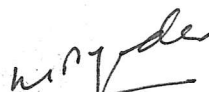
1. Required guest/outsourced faculty will be engaged purely on contractual basis for one semester only (Sem. I, Session 2026-27).
